

## Letter to parents from DOBCEL: Endorsement and Opt-Out

Ballarat Diocese Flare Primary Literacy Strategy and La Trobe University Human Ethics Committee

Dear Parents and Guardians,

The Ballarat Diocese is partnering with the School of Education at La Trobe University to roll out and evaluate a new approach to initial literacy instruction in Ballarat Diocese schools, including the school attended by your child/children. This approach has already been piloted successfully in several Diocesan schools and is being applied to the majority of primary schools across the Diocese as of early 2025.

The aims of the research are:

- To determine whether this approach results in measurable gains in students' reading, writing, and spelling skills, as against our routine practices in recent years.
- To document student wellbeing (behaviour and emotional adjustment) in response to the new teaching approach.
- To examine changes in teacher knowledge and confidence in the teaching of literacy, and to understand teacher views about this new way of teaching.

The purpose of this letter is to let you know that information about all students' classroom progress on reading, writing, and spelling will be collected and analysed as part of this project. This information will be collected on children in schools that are trialling the new approach and also on schools that for the time being, are continuing with current practices. De-identified Year 3 and Year 5 NAPLAN Literacy data will be used as part of the evaluation and made available to the La Trobe University research collaborators. We will create a unique code for each child, made up of letters and numbers, so that when information is transferred to La Trobe University, it does not contain names of schools, teachers, or individual students. Your student's de-identified learning data will be used in the process of assessing the effectiveness of the new approach. When reports are published out of this work, there will be no names of participating schools, teachers, or students included.

All student data used will be de-identified, transferred, stored, and ultimately destroyed in ways that comply with privacy legislation and the requirements of the La Trobe University Human Ethics Committee.

**If you do not wish for your child/children's data to be used in the study, you may opt out by completing the form below and returning it to the classroom teacher. Your child/children's data will not then be included in any analysis. Even if you do initially agree, you may choose to withdraw your child/children's data at any point later on. If you are happy for your child / children's de-identified data to be used as part of the research, you do not need to do anything in response to this letter. By not responding you are endorsing the use of de-identified data for the research.**

Your decision (either way) to allow your child/children's de-identified data to be used as part of the research will not in any way affect your relationship with your child /children's school, the Ballarat Diocese, or La Trobe University. If you initially decide to opt out, but change your mind later, that can be accommodated up until the time that data analysis commences.
